## **ROCKVILLE FISH & GAME SUMMER PISTOL LEAGUE**

### **GENERAL INFORMATION:**

NRA Registered League Tournament. All scores fired in the 2-Gun category will be sent to NRA after the final match of the series of ten matches. There will be a fifteen-week duration to allow for make up matches. You must be a member of the NRA. No scores from the .22 Cal match will be sent to the NRA.

THE YANKEE 2 GUN 600:

Any Semi-Auto Pistol or Revolver in 22 caliber and any center fire. Any sighting devise.

### **THE REBEL.22 Cal. 600:**

Any .22 Cal. Semi-Auto Pistol or Revolver may be used. Any sighting devise. Fired simultaneously with the 2-Gun entries.

### **CLASSIFICATIONS:**

.22 Cal. Entries. New entries will shoot their first match as unclassified. Temp. books will be used until 180 rounds have been fired. The shooter will then be classified for the remainder of the tournament.

Note: NRA requires 10 shooters to complete 10 matches to submit scores to the NRA

### **REGISTRATION & ENTRY:**

Season fee for ten matches is \$40.00. Payment is in advance of the first match. No individual match fee will be allowed. Payment may be mailed in prior to the first match. The first match will be on Tuesday Evening, **May 9, 2023**. Entries will be taken for the season at this time.

### **MATCH SCHEDULE:**

Tuesday evenings starting on **May 9, 2023**, and continuing for 14 weeks to **August 8, 2023**. three extra matches are included for make-ups if necessary. Only first **TEN** matches turned in count for awards. *No match substitutions are allowed.* Please be sure to turn in the score card at the conclusion of each match.

**48** competitors only - Name the relay wanted on the R & E Card. The first **48** entries received will be honored, so be sure to register as soon as possible. Completed by legal sunset time.

**AWARDS:** (For only the first ten dated match score cards submitted).

1. OVER-ALL WINNER

2. FIRST PLACE in each class provided at least two competitors compete in each class. Otherwise competitors will be grouped into another class.

3. SECOND PLACE in each class provided at least FIVE competitors in a class.

4. A THIRD PLACE award will given if there are 8 or more shooters in a class.

DNC means, Did Not Complete 10 matches for award purposes. However, they will be listed in the bulletin and will count for total competitors having entered the tournament and will affect the pay-off for all competitors. NO DUPLICATE AWARDS! NOTE: 11 two gun competitors must complete 10 matches for the NRA to accept scores. PLEASE BE ON TIME! Bring a clip board, foul weather gear and warm clothing for the matches.

### **DIRECTIONS:**

From Route 84 take exit 67 to Route 31 South to Fish and Game Road on the right. Proceed past the Club house (left) to the entrance (dirt road) thru open gate and then bear left at about 100 yards to the pistol range. Don't panic you will find us at the far end of the area at the covered pistol range
